## **Food Exhibitor Rules & Regulations**

1. Application must be postmarked by April 7, 2018.
2. Exhibitors can begin setting up no earlier than 6am Saturday, April 15. All vendors must be set up and ready by 9am. All vehicles must be parked in designated parking by 8:45am. The festival hours are 9am-4pm. Vendors MUST be off the street & loaded up by 5 pm.
3. This is an out-door event which will take place around the Colquitt County Courthouse square. There will be no refunds due to inclement weather.
4. All spaces are 12x12. Food vendor spaces are \$150.00. This includes electricity. You must bring your own extension cords, tables & chairs.
5. Applications not returned by the specified deadline will not be given space request consideration.
6. All vendors are responsible for collecting Georgia sales tax (7%).

\*Please understand we will only allow a certain number of food vendors into our show, due to the close proximity to our downtown restaurants.
