- 1. Application must be postmarked by March 29, 2023.
- Exhibitors can begin setting up no earlier than 6am Saturday, April 16. All vendors must be set up and ready by 9am. All vehicles must be parked in designated parking by 8:45am. The festival hours are 9am-3:30pm. Vendors <u>MUST</u> be off the street & loaded up by 4:30 pm.
- 3. This is an out-door event which will take place around the Colquitt County Courthouse square. There will be no refunds due to inclement weather.
- 4. All spaces are 24x24. Food vendor spaces are \$200.00. This includes electricity. You must bring your own extension cords, tables & chairs.
- 5. Due to liability & food safety, only licensed vendors will be accepted. This includes an up-to-date Food Permit.
- 6. Applications not returned by the specified deadline will not be given space request consideration.
- All vendors are responsible for collecting Georgia sales tax (7%).

*Please understand we will only allow a certain number of food vendors into our show, due to the close proximity to our downtown restaurants.
